# Frequently Asked Questions (FAQs) for Specialists

## Do specialists qualify for the CMS EHR Incentive program?

YES. Specialists qualify for the CMS EHR Incentive program.

### Does NJ-HITEC provide services to Specialists?

NJ-HITEC was originally chartered to help Primary Care Physicians (PCPs). After 2 years, NJ-HITEC is now expanding our reach and offering our services to Specialist for a nominal fee.

#### Do I need to see Medicare patients?

Yes. Eligible professionals who have \$24,000/yr. Medicare Part B allowable charges and demonstrate that they are using a "certified" EHR in a "meaningful" way can earn incentive payments.

#### What if I see Medicaid patients?

Your practice qualifies with 30% of its encounters paid by NJ Medicaid, we will assist you determine which incentive program is best for you or your practice.

#### What is the timing of the Incentives?

#### Is the EHR incentive per practice or per physician?

The EHR incentive program is per physician, not per practice. 3 physicians – 3 times the incentive, Dr X, Dr Y, and Dr Z are each eligible to attest and earn the incentive.

#### What is Meaningful Use?

Meaningful Use is using a certified system to structure your data. The U.S. Department of Health and Human Services defines "Meaningful Use" by the following criteria:

- Use of a certified EHR technology with ePrescribing capability
- Connectivity (interoperability) for the exchange of patients' health information
- Compliance with clinical quality measure reporting (PQRS)

#### Do I really have to do this? Do I have to have an EMR?

No, but penalties have been officially released and begin in 2015.

#### How can NJ-HITEC help my specialty practice?

NJ-HITEC's Meaningful Use team will provide support and services to assist you in obtaining the Meaningful Use incentives.

#### Does the federal government keep my data?

No, only the numerators and denominators - No personal health information is shared.

#### Is this Obamacare? (Affordable Care Act)

No, this is the EHR incentive program with bipartisan agreement. The Affordable Care Act (Obamacare) is insurance coverage for all Americans.
